Jay: can Pat please share his knowledge based decision making with us so we know about this alternative Pat: mentioned we need to set realistic goals, rather than dealing with everything on the table We need to set up a winning streak (still no idea on the practicalities of what Pat just said) Its criticism, not helpfulness. Val G: wants to talk about this huge change that has been happening. We are all floundering around not knowing what we are doing, which is normal, as this will take time. Ie what are we meeting for each month? When will the conference be? What kind of changes do we want? Is this happening too soon cause we are now trying to figure out what we are considering this big change. It feels a little scarey right now.
