Conference Planning Committee Report June 2023

Chair of Planning Committee (Matt B) reported: July 2023, Board Meeting

Hello everyone, since the last Board Meeting Conference Report we've had the June Pre-Conference. Among the major items discussed and voted on was the beginning hours of each day of the Conference, which was established as 2pm ET. This time was agreed on as it's not too early for Australia (5am) and not too late a start for Europe. We're hoping that these times encourage maximum worldwide Delegate participation. We (The CPC) also presented the Draft Agenda put together by the Skeleton Crew-(Populated with must have Items like Delegate Packet Review and Committee Reports etc.). It was well received with only one suggested change which was for me to draft a topic for discussion based on Rotation of the Board of Trustees and the need for service. This is the full (carried) motion.

Motion: Draft a proposal to put forward a discussion at the 2023 WS Conference: the importance for the rotation of service, a structure for filling board trustee vacancy, actions each board of trustees performs, and members' desire to serve.

I with the help of the Board chair have completed this, it will be added to the full drafted Agenda to presented to the August Agenda Setting meeting and if agreed to the August Pre-Conference. We also reviewed the pamphlets for the Special One-Day conference on July 15th. I will be facilitating that day and I'm very confident that with all the diligence and hard work that the Literature Committee put into the preparation that it is going to be an extremely productive Special Conference.

With the deadline for Submission of Motions & Topics passed, we received two Topics. It's looking like the majority of the Conference will consist of the Literature Approval process and Literature themed topics. This of course is all subject to Pre-Conference Approval.

The Conference Planning Committee had the June meeting where we filled in the Draft Agenda with the Submitted Motions and Topics, ready to present at the August 19th Pre-Conference. A reminder that this

will be the last scheduled Pre-Conference before the Conference itself, though of course the Conference Planning Committee Meetings running up to the Conference will continue as scheduled. The CPC will also meet on Saturday the 22nd of July at 4pm to organize and finalize the Delegate Packet for distribution and posting by August 15th.

We have sent out a Recruitment flyer for service at the Conference for the Delegate Registration Team and behind the scenes at the Conference. Thanks to Allegra for formatting and distributing this. Though I am reticent to end this report on a 'negative' note, I was concerned about the lack of attendance at the Last Pre-Conference which numbered six people. (Half were Delegates). I'm hoping that the August Agenda Setting meeting and Pre-Conference will have better attendance. Stating that it's the last one(s) before the Conference hopefully will encourage attendance. Also, I'm confident that increased engagement with Delegates between now and the Conference will help.
