## LITERATURE COMMITTEE: January - March 2024 Quarterly Report to the Board of Trustees

#### **Members Stories:**

- Hoping to hold Members Stories Workshops in the UK and Europe, with the idea of making these available in language, culture and timing convenience. Some contacts have been approached and they are taking this idea back to their meetings and groups.
- 15 stories have been collected, including two from Russia (in English) and one in Spanish

## **Non-Founder Written Pamphlets:**

- A revision by the Subcommittee of *The Creative ProcesZ* was read and discussed. It was tabled as a possible new project to take up in the future, given the revision and/or additional input it could take. The feeling is that it was a very big topic and the pamphlet was too much of a reflection of a single person's experience. Other discussion included concern that there didn't seem to be a grounding in recovery or working Steps, that this could become part of a larger publication in the future, that the connection to a spiritual process is not clear, does it reflect a collective voice?
- Copies of three additional pamphlets we didn't have copies of yet have been located.
- The subcommittee is not currently meeting and has no further mandate from the Literature Committee at this time

## Traits, Talents and Tools:

- Talents work by the Subcommittee is complete, and they are being reviewed by the Literature Committee. It was decided to include the words, "In recovery" in the front of each so as to remind us the possibilities in each one, and so that they can be considered individually.
- The Subcommittee is undergoing a review of the *Traits* to put them in the past tense. It is also exploring the idea of adding a "qualifier" to the beginning of each one.

## Non-Conference Approved Literature:

• Multiple discussions on this topic, including a reading of the letter sent to the Delegates regarding the removal of this Literature for sale by A.R.T.S. No specific recommendations made or actions taken by the Literature Committee, although there has been discussion.

## Compiled List of Ideas and Thoughts for Next Projects:

- A series of writing workshops focused on personal stories at it relates to each Step (hold the workshops one Step at a time)
- Come up with good writing on the Steps, Step Writing
- Writing on the Traditions
- Writing and talking about Sponsoring, what do we get from sponsoring
- Provide a structure of working each Step, Tradition and Concept together, one by one.
- A book of "12, 12 and 12" (Steps, Traditions and Concepts of Service)
- There are powerful methods of working Steps out there in 12-step recovery, what could be a third model?
- Everyone's Step work is different. Lots of ways of working Steps and some people need more guidance than others.
- Some Fellowships (such as AA) do not have workbooks. Usually, sponsorship is one-on-one and you work the Steps the way your sponsor shows you how, based on how they learned
- If we decide we want to develop "workbooks" they can be very simple, and presented as an optional guide with some questions and assignments
- Lots of the questions in the non-Conference-Approved Workbooks were not ARTS-specific; used by or borrowed from elsewhere. We can do this too.
- Underlying tone of how we have harmed ourselves, and the amends we do for ourselves is useful in Step guidance
- Find ways to talk about "what are we recovering from?"
- We have been given the gift of creativity. We can accept a constructive force in ourselves, and hope whatever we develop and provide keeps that in mind
- No need for us to hustle and hurry, we can do this right
