Motion 1 by Vicki, 2nd Donna

Set up a P&P committee for ARTS members to express their views on all vital matters of policy. Passed unanimously.

As we began to read Article 3 where we had left off in April, it became apparent that we had too many questions about the content to be unable to accept the charter as written. We embarked on a new path and came up with the following draft policy based on the discussions that arose. We are not sure where this will fit into the charter if at all but we worked hard. Vickie, chair of P&P, Policy and Procedure, and knows about al of this, seemed excited that we had accomplished this. She wrote this document as we discussed it and changed it as we changed the language.

Motion 2: The Conference will also be the vehicle by which A.R.T.S. members express their views upon all vital matters of policy. By Vicki 2nd Amy Passed unanimously

Delegates 'Role in the Conference: The Conference will act for A.R.T.S. in the perpetuation and guidance of its world services, and it will also be the vehicle by which A.R.T.S. members express their views upon all vital matters of policy and all potentially hazardous deviations from the Twelve Traditions and Twelve Concepts of Service in A.R.T.S. Anonymous. At the Conference, GSRs, as trusted servants, consult with the members they represent and are free to vote as their conscience dictates; they are also free to decide what questions should be taken to the group level.

Delegates vote on issues affecting the entire Fellowship. They elect Trustees, approve literature, provide guidance for public outreach, establish policies and procedures, and maintain the integrity of the foundational documents*. Delegates may serve on committees. The group conscience as expressed at the WSC, is binding by program tradition, as long as it does not interfere with A.R.T.S. nonprofit corporate status.

Delegates role:

Before the Conference,

- Delegates discuss at their meetings motions in the delegate packet that will be addressed at the
 upcoming Conference, and solicit guidance on how they should vote.
- The GSR is the link between group conscience meetings and the Conference. How do groups propose motions for consideration by the Conference.
 - It is recommended that motions be submitted by delegates after a group conscience in their meeting.
 - Individuals may also submit motions which may be considered for inclusion in the Delegate packet.
 - The following group conscience platforms are responsible submitting motions to the Conference for consideration at the Conference.
 - A.R.T.S Board
 - Board committees
 - Conference committees.
 - The Conference Planning meeting.
- Motions proposed for the Conference should be submitted to the World Service Office through the form available on the website.
- The following service platforms may, by group conscience, submit motions to the Conference Planning Committee:
 - A.R.T.S Board
 - Board committees
 - Conference committees.
 - The Conference Planning meeting.
- There will be a deadline set by the Conference Planning Committee so that the motion may be formulated with Background and Rationale for the Delegate packet.
 - o Proposed motions will be referred to the appropriate committee.
 - o If the committee needs further clarification, they will communicate with the proposer.
